

Michaud Announces Release of \$3.3 Million in Health Center Funding for Maine

WASHINGTON, DC – Today, Congressman Mike Michaud announced that the U.S. Department of Health and Human Services will release \$338 million to expand services offered at community health centers nationwide. The funding was made available by the American Recovery and Reinvestment Act (H.R. 1). Maine is receiving a total of \$3,345,917 in funding. The details of Maine’s share of the funding are attached.
